WHAT HAPPENS NEXT?

1. Seafood Cornwall Training (SCT) will check and verify the information you have provided.
2. Cross checks with other PDF with PLB projects will ensure that there is no duplication via Seafish UK, Plymouth City Council, SW Handline Fishermen's Association, Welsh project (Seafish), Cornwall Council, MCA, Auctioneers and Harbour Authorities.
3. You are required to attend a safety workshop near your port or home in Cornwall.
4. Successful applicants will be informed and invited to workshops with full details of the venue and time.
5. If you are not successful you may appeal to Cornwall Council via Seafood Cornwall Training.
